CALL TO ORDER

MINUTES

TREASURER'S REPORT

EXECUTIVE DIRECTOR'S REPORT

Tennis Court Lighting

Research was conducted on the tennis court lights and it was confirmed that courts 1 - 5 do have halogen bulbs rather than LED bulbs. The current bulbs are at the maximum allowable wattage permitted by City of Scottsdale in our approvals. Changing the bulbs would require retrofitting the fixtures and city permits. The reservation system shows approximately 55 tennis reservations made from May through November between the hours of 5pm to 9pm. The Physical Property Committee reviewed this information and at this time the recommendation is not to proceed with changing bulbs.
